



**PUBLIC AGREEMENT**  
**on the procedure for publishing authors’**  
**articles in the journal**  
**Prospecting and Development of Oil and Gas**

### **1. General Provisions**

1.1. This document constitutes a public offer (hereinafter – the Offer) by the publisher of the journal Prospecting and Development of Oil and Gas Fields to an indefinite number of persons to enter into an agreement under the terms set out below (Article 633 of the Civil Code of Ukraine).

1.3. The publication of this Offer on the official website of the journal constitutes an invitation to enter into an agreement under the conditions specified herein.

### **2. Parties and Terms**

2.1. The Author – a natural person who has created an article and submits it for publication; within the scope of this Agreement, acts as the Licensor.

2.2. The Publisher / Editorial Office – the journal Prospecting and Development of Oil and Gas Fields; within the scope of this Agreement, acts as the Licensee.

2.3. Materials – the author’s articles and accompanying files intended for publication in the Licensee’s editions.

### **3. Procedure for Conclusion (Acceptance)**

3.1. The Agreement is concluded by the Author’s full and unconditional acceptance of its terms, without any modifications, exclusions, or reservations (Article 642 of the Civil Code of Ukraine).

3.2. Acceptance is deemed to occur when the Author submits their Materials for publication in the Licensee’s editions following prior approval of the article’s content with the Editorial Office.

### **4. Subject of the Agreement**

4.1. This Agreement defines the procedure for publishing authors’ articles in the journal and the granting of a Licence for the use of the work under the terms specified herein.

### **5. Licence and Scope of Rights**

5.1. The Author retains copyright in their work and grants the Licensee the right of first publication under the terms of the Creative Commons Attribution International (CC BY) licence.

5.2. Within the framework of this licence, the Licensee shall have the right to:

5.2.1. publish articles in English and distribute their printed versions;

5.2.2. translate articles into English (for those originally written in Ukrainian) and distribute the printed versions of the translations;

5.2.3. distribute electronic versions of articles and electronic versions of English translations (for articles written in Ukrainian) by any electronic means, including on the official website of the journal, in electronic databases, repositories, and similar platforms.

### **6. Confirmation of Rights Allocation**

6.1. The publication of the author’s material in the journal Prospecting and Development of Oil and Gas Fields constitutes confirmation of the allocation of rights between the Licensor and the Licensee under this Agreement.

## **7. General Procedure for Publication**

- 7.1. Preliminary approval of the article's content between the Author and the Editorial Office.
- 7.2. Submission by the Author of the Materials for publication (which simultaneously constitutes acceptance of the terms of this Agreement).
- 7.3. Editorial preparation and publication of the article by the Licensee in accordance with the rights granted under Section 5.

## **8. Liability of the Parties**

- 8.1. In the event of non-performance or improper performance of obligations, the Parties shall bear liability in accordance with the applicable legislation of Ukraine.

## **9. Dispute Resolution**

- 9.1. Any disputes or disagreements shall be resolved through negotiations between the Parties.
- 9.2. If no agreement can be reached, the dispute shall be settled in court in accordance with the laws of Ukraine.

## **10. Final Provisions**

- 10.1. In all matters not expressly regulated by this Agreement, the Parties shall be governed by the legislation of Ukraine.
- 10.2. Submission of Materials by the Author constitutes full and unconditional acceptance of the terms of this Offer.
